

# What You Need to Know About the Connecticut Energy Crisis



When households struggle to access heat, power, or water, the impacts extend far beyond the loss of basic utilities. Chronic health conditions worsen, daily stress intensifies, and the simple routines that allow families to thrive become increasingly fragile.

The challenge of energy insecurity is not just an individual burden—it is a shared community issue that calls for collective action. When one family falls into crisis, the ripple effects move throughout the community: schools, workplaces, healthcare systems, and local economies all feel the strain.

Ultimately, confronting the energy crisis is about more than restoring power or reducing bills. It is about ensuring dignity, stability, and opportunity. It is about giving every person the chance to grow, to participate fully in community, and to live a healthy, secure life. And it is about recognizing that when we act together—when we share our stories, our strategies, and our determination—we have the power to create an energy future that is resilient, just, and accessible to all.

# Emergency Assistance Programs



## Emergency Energy Assistance Program

Our Emergency Energy Assistance Program continues to act as a vital safety net for thousands of families across Connecticut navigating the challenges of energy insecurity. As costs continue to rise, the need for support has surged. Each time we open assistance applications, we receive a strong and immediate response from those in need. This growing demand reflects not just the scale of the energy crisis in Connecticut, but the shared responsibility we carry as a community to ensure that no household is left in the dark or the cold.

In fiscal year 2025, we served residents in 167 of Connecticut's 169 cities and towns. At GPCT, we see

more than numbers—we see neighbors, partners, and families whose resilience inspires our work. Every story shared with us strengthens our collective resolve to address energy insecurity through compassion, collaboration, and action.

- GPCT proudly partners with over 50 community organizations throughout the state as Application Support Centers (ASCs). ASCs are vital to the work we do, providing information about GPCT's Emergency Energy Assistance program and submitting applications on behalf of households both in-person and over-the-phone, therefore expanding access to our services.
- We maintain partnerships with over 250 fuel and utility vendors across the state, ensuring households can access their preferred vendor and receive assistance on their utility bills.

## Emergency Water Assistance

GPCT is proud to continue our strong partnerships—including with Aquarion Water Company, Connecticut Water Company, and The Metropolitan District Commission (MDC)—to expand access to essential bill payment assistance and discount rate programs. Our efforts reflect a shared commitment to ensure every household has reliable access to safe, affordable water, and they demonstrate what becomes possible when organizations unite to support community well-being.

By working collaboratively with our water partners, GPCT helps remove barriers for families facing financial strain, connecting them to essential resources that will help them meet basic needs and remain in their homes. We are building a model for impactful collaboration—one where utilities, nonprofits, and communities work side-by-side to strengthen affordability, promote equity, and create a more resilient future for households across Connecticut.

# Research and Community Engagement

Our Research and Community Engagement team continued to expand our community-driven approach to understanding and addressing energy insecurity across Connecticut. Growth begins with listening—deeply and respectfully—to the people most affected. Through listening sessions, focus groups, and one-to-one conversations, GPCT utilizes a collaborative research model shaped by the lived experiences of our state’s most vulnerable residents.

Children, seniors, working families, and individuals with medical needs are not just participants in our research; they contribute to real solutions. By uplifting their voices as part of our mission, we aim to keep people safe in their homes and improve residents’ health and well-being.



## Climate Smart Technology Research Leads to New Department of Energy Project

In August 2024, we concluded our Climate Smart Technology project, which highlights the critical needs of home medical device users living in affordable housing—and how their well-being is linked to climate resilience.

This study laid the groundwork for the Climate Resilient Energy Codes initiative, funded by the U.S. Department of Energy, in partnership with Clean Energy Group, American Microgrid Solutions, Connecticut Green Bank, CT Department of Energy & Environmental Protection, CT Insurance Department, New Buildings Institute, and Yale School of Public Health. In the first project phase, our team gathered feedback from 80 residents through listening sessions to inform the code development process, culminating in a report published in March 2025.

- **94 residents** shared their experiences around the uncertainty of power outages while living in affordable housing.
- **Transparency and communication** are essential to effective code implementation, which has a direct impact on occupants’ well-being and living conditions. Proper communication ensures residents stay informed about proposed measures and implementation timelines.



# Research and Community Engagement



## GPCT Shares Advocacy & Research Innovations at National Energy & Utility Affordability Coalition Conference

In June, GPCT stepped onto the national stage at the 2025 National Energy and Utility Affordability Coalition (NEUAC) Annual Conference to share how our emergency assistance programs, regulatory advocacy efforts, and community research initiatives are confronting utility burden.

Chief Policy & Public Affairs Officer Gannon Long and Michelle Royce Williams of Connecticut Water Company showcased the impact of corporate-nonprofit collaboration, demonstrating how our joint

efforts support limited-income water customers statewide. Our presentation underscored a key belief at GPCT: when organizations work together, we can reach farther, respond faster, and build stronger pathways to affordability.

Meanwhile, Chief Operating Officer Darlene Yule, Community Research & Education Coordinator Claire Lee, and Dr. Annie Harper of Yale University shared insights from our community-driven research, *Empowering Energy Justice and Resilience Through Community Engagement*. Their session highlighted how centering the lived experiences of residents can drive meaningful policy and programmatic change. Together, their work demonstrated that true energy justice grows out of collaborative leadership—neighbors, researchers, and advocates working side by side to build healthier, more equitable, and more resilient communities across Connecticut.



## Gas Assistance Program (GAP)

In March 2025, GPCT joined Neighborhood Housing Services of New Haven (NHS) to launch the Gas Assistance Program (GAP), to support gas ratepayers experiencing difficulties across the state. By removing critical health and safety barriers—such as mold, asbestos, and broken water heaters—at no cost to the residents, GAP removes barriers for income-eligible families to pursue long-term energy efficiency improvements.



This fiscal year, the GAP program made a measurable impact on 20 Connecticut households, **completing 33 projects.**

## Regulatory Engagement at the Public Utilities Regulatory Authority (PURA)

Since 2019, GPCT has steadily increased our participation in PURA dockets. Recognizing that hundreds of thousands of Connecticut households face energy and utility insecurity, GPCT is committed to joining regulatory proceedings that impact access to heat, power, and water for limited-income and medically vulnerable communities.

Our team is dedicated to bringing real-life experiences into PURA's decision-making processes. We submit written comments, provide data from our programs and client testimonials, and join technical and public meetings to ensure the voices of those most impacted are heard.






# Advocacy

**S.B. 1560**

## Legislative Advocacy

From January 8 through June 4, 2025 the Connecticut General Assembly considered bills addressing the intertwined challenges of energy, housing, health, and affordability. Working with partners, advocates, and residents, we defended working families from cuts to essential assistance, protected critical medical safeguards, and ensured continued access to fair payment plans. We also championed policies to reduce rate shocks for water customers and expand access to energy efficiency and weatherization services that help families save money and stay safe in their homes. Elevating the real stories of our clients built bipartisan support and momentum for long-term, community-driven solutions.

- **LIHEAP Block Grant Allocation Plan** – GPCT testified in favor of Connecticut’s plan to deploy federal energy assistance funds.
- **H.B. 6777** – GPCT’s testimony helped pass legislation reducing water rate shocks for ratepayers.
- **H.B. 6926** – GPCT’s verbal and written testimony highlighted our partnership with NHS of New Haven, removing weatherization barriers through our Gas Assistance Program (GAP).
- **S.B. 647** – GPCT helped stop this bill, which would have eliminated funding for energy assistance, arrearage forgiveness, energy efficiency, and other programs.
- **H.B. 7088** – GPCT supported a section in the bill requiring PURA to investigate medical protection policies, which passed.



GPCT’s testimony highlighted the importance of energy assistance for families who can’t afford their bills. We successfully advocated for a \$1.5 million allocation for emergency assistance for Fiscal Years 2026 and 2027.

## Federal Issues

In May 2025, CEO Perkin Simpson joined Senators Richard Blumenthal and Chris Murphy, along with Department of Social Services Commissioner Andrea Barton Reeves, at a press conference advocating for the Low-Income Home Energy Assistance Program (LIHEAP) amid federal uncertainty. In June, GPCT submitted congressional testimony in support of LIHEAP funding and rapid deployment. While GPCT’s policy agenda remains focused on the state, we expect our federal advocacy to continue in the coming year.



# Celebrating Our Legacy



At the end of the 2025 fiscal year, Operation Fuel officially rebranded to GPCT. For nearly five decades, Operation Fuel has been a lifeline for Connecticut families facing energy insecurity—built on the belief that communities are strongest when we care for one another. Since our founding in 1977, our impact has been made possible through collective action: advocates, utility leaders, faith leaders, donors, and neighbors coming together to ensure access to heat, electricity, and water for Connecticut residents. That shared commitment has allowed us to respond in moments of crisis, while strengthening the systems that support long-term stability.

Today, as GPCT, we honor that legacy while looking boldly toward the future. Our

rebrand reflects an expanded vision—one that keeps emergency assistance at our core while advancing energy equity for generations to come. We are deeply grateful to everyone who has joined us and continues with us on this journey. The challenges ahead demand collaboration, innovation, and shared responsibility. Our community continues to prove that lasting change is powered by coming together.
